Divorce in Texas: At least one spouse must have resided in the State of Texas for six (6) months prior to the filing for divorce. There is a thirty (30) days waiting period from the date you and your spouse filed for your divorce and have submitted a completed divorce agreement form as well as other forms to the court for review before your divorce will be granted and final.
