Various types of housing and their specific requirements

An employee was provided with fully furnished accommodation (i.e. a residential apartment) with an AV of \$30,000 from 1 Jan to 31 Dec. The total rent (inclusive of rent for furniture and fittings) paid by the employer in the year was \$50,000. The total rent paid by the employee in the year was \$6,000.

As a general rule, the IRS considers employer-provided housing to be a fringe benefit, and fringe benefits count as taxable income for an employee.. An exception is granted if the lodging is for the convenience of the employer, is on the business's premises, and is provided as a condition of employment.
