All real estate license applicants are required to take the state of Nevada license exam. The exam is made up of two sections: state law (40 questions / 90 minutes) and national law (80 questions / 150 minutes). The cost to register for the exam is \$100. Upon passing the exam, you have up to 12 months to submit your license application.

Broker Licensing | NV Real Estate Broker License ...

Take 120 hours of approved education at a certified Real Estate Pre-License School as outlined in the Real Estate Pre-License Education Curriculum. This education must be completed no longer than one year before applying for a license. Take and pass the Sales Agent exam. A license request must be made within 90 days of passing the exam.
