New York Insurance Prelicensing State Requirements

Each line of authority in New York varies in required pre-license education hours. This means that if you wish to get a Property and Casualty license, you must take ninety (90) hours of pre-licensing, and for Life, Accident, and Health you must also take forty (40) hours. You will receive a certificate upon completion of the course.
