The Ninth Circuit has made clear that "[i]n exercising its discretion, 'a court must be guided by the underlying purpose of Rule 15 -- to facilitate decision on the merits rather than on the pleadings or technicalities.'" *Leighton*, 833 F.2d at 186, quoting *U.S. v. Webb*, 655 F.2d 977, 79 (9th Cir.'81).

### Amendment Of Pleadings Defined and Explained

(There was a long tradition in the English common law of highly technical pleading requirements.) The rules for pleading, and the concept of simplified pleadings, are set out in Section III of the Federal Rules. The complaint Rule 3 states that a civil case is started when the plaintiff files a complaint with the district court.
