USCIS Published 2019 Poverty Guidelines for Affidavit of Support. For family-based immigration petitions, the petitioner must submit an Affidavit of Support on behalf of the beneficiary or beneficiaries. The Affidavit of Support is used to demonstrate to the U.S. government the immigrant will not become a public charge, which means the immigrant will not need to rely on the U.S. government for financial support.

To qualify for the reduced fee, your documented annual household income must be greater than 150 percent and not more than 200 percent of the Federal Poverty Guidelines (FPG), at the time of filing, based on your household size. The secretary of the Department of Health and Human Services establishes the Federal Poverty Guidelines annually.

The poverty guidelines may be formally referenced as “the poverty guidelines updated periodically in the Federal Register by the U.S. Department of Health and Human Services under the authority of 42 U.S.C. 9902 (2).”

If you, the sponsor, are on active duty in the Armed Forces of the United States, and the immigrant you are sponsoring is your spouse or child, your income only needs to equal 100% of the U.S. poverty level for your household size. To see if you are above the poverty level, see Form I-864P, HHS Poverty Guidelines for Affidavit of Support.

Affidavit of Support | USCIS

The Federal Poverty Guidelines are federally set “poverty lines” that indicate the minimum amount of annual income that an individual / family needs to pay for essentials, such as housing, utilities, clothing, food, and transportation.
