However, the ADPA contains the following principles: Data secrecy: Sec 6 ADPA provides for a general principle of data secrecy and obliges all data controllers, processors and their employees to keep all personal data strictly confidential. Further, Sec 5 ADPA provides for a specific obligation for Data Protection Officers to keep all received information strictly confidential.

The principle of client-lawyer confidentiality is given effect by related bodies of law: the attorney-client privilege, the work product doctrine and the rule of confidentiality established in professional ethics.

## **Rule 1.6 Confidentiality of Information - Comment**

The duty of professional secrecy ensures the confidentiality of discussions between a lawyer and his or her client so that no third party can gain access to the information exchanged. Lawyers are not entitled to disclose information provided by their clients and should never be forced to do so. The information exchanged is privileged.

## **Professional Secrecy of Lawyers in Europe**

The attorney-client privilege is a rule that preserves the confidentiality of communications between lawyers and clients. Under that rule, attorneys may not divulge their clients' secrets, nor may others force them to.

## **Confidentiality and Limitations of Attorney-Client ...**

Professional secrecy in GERMANY is no longer solely based on the provisions of the Criminal Code, but also on the law regulating the legal profession: §43 a II of the Bundesrechtsanwaltschaftsordnung – BRAO, German Lawyers Act: "The lawyer is bound by professional secrecy obligations. Client-Lawyer Relationship (a) A lawyer shall not reveal information relating to the representation of a client unless the client gives informed consent, the disclosure is impliedly authorized in order to carry out the representation or the disclosure is permitted by paragraph (b).
