Attorneys still using this type of boilerplate approach to their document requests responses do so at their own risk. Federal Rule of Civil Procedure 34, which governs document request responses, was revised in late 2015 to require that responses now "state with specificity the ground for objecting and state whether any responsive materials are being withheld on the basis of that objection."
