En español | When a Social Security beneficiary dies, his or her surviving spouse is eligible for survivor benefits. A surviving spouse can collect 100 percent of the late spouse's benefit if the survivor has reached full retirement age, but the amount will be lower if the deceased spouse claimed benefits before he or she reached full retirement age.

Benefits which may be affected include universal credit, housing benefit, and council tax support. Your compensation payment will not be counted towards your savings threshold for 52 weeks from the date it is paid (even if the first payment is an interim payment), but the way in which you spend it will be examined for "reasonableness" of someone who is in receipt of your type of benefit.

Will a Compensation Claim Affect My Benefits?

Social security benefits are also paid out based on the value of your assets and savings, such as a car or house. Owning assets over the threshold amount can nullify your right to claim benefits. In general, all foreigners who live and work in the Netherlands must pay into the Dutch social security system.
