If this is the case, a probation officer will gather all sorts of information about you and present it in a report to the Court.

When considering parole for those offenders who will become statutorily eligible for parole consideration and who are serving less than a life sentence, the Board reviews a recommendation of months, or a percentage of the sentence, to serve. This recommendation is obtained from the Parole Decision Guidelines system, which accounts for the severity of the crime and the offender's risk to reoffend.

“Truth in Sentencing” in Georgia

Raised felony theft threshold from \$500 to \$1,500. Created graduated scale of penalties based on value of stolen items, reducing the maximum sentence for items valued at less than \$5,000. Increased minimum and maximum sentence for the most serious theft (\$25,000 and above) Shoplifting.

Georgia law identifies seven felonies, known as the "seven deadly sins," that require mandatory minimum sentences, including kidnapping, armed robbery, rape, aggravated child molestation, aggravated sodomy and aggravated sexual battery. These offenses result in 10 years without possibility of parole.

Georgia sentencing guidelines. Unlike the federal sentencing guidelines which classify crimes by levels of severity, Georgia state law doesn't make these delineations. Instead, every felony crime carries its own range of punishment, and the judge determines the severity of the sentence within that range based on the circumstances of the case.

Defendants who have a prior felony conviction in Georgia and who served time in prison for the offense (or those with an out-of-state conviction for a crime that would be a felony in Georgia, had it been committed there) must be given a sentence of life without parole. (Ga. Code Section 17-10-7.)
